




## Department in Focus

## Interview with Head of ERP Development Section



Head of ERP Development Section, Mr. Vinod Nair

### What is the significance of the Certified for Windows 2012 award?

The Certified for Windows Server 2012 certification is awarded to hardware and software solutions that meet Microsoft standards for compatibility and recommended practices with the Windows Server 2012 operating system. Certified applications have been tested by Independent Software Vendors (ISVs) using technical specifications and tools required by Microsoft. In other words this certification means OPTIMUM ERP systems have proved its worth as a reliable system meeting the high standards set by Microsoft.

### What technical changes have taken place in your existing software?

OPTIMUM Version 11 has been developed with Microsoft.net Framework 4, which helped us to enhance the system, starting from security to the look and layout of the System. We've added a lot of features to the new OPTIMUM version, such as cross-browser compatibility, full screen mode, swapping branches, notifications, and many more to each module.

### In what way are your customers going to benefit from this certification?

As far as our customers are concerned, this is an assurance that their decision to opt for OPTIMUM has been endorsed by such a big name as Microsoft. This certification adds value to our credibility and acceptability among our existing and potential clients.

### How long did it take to reach this level?

We have been Microsoft Gold Certified Partner since 2009 and have been following their standards for a long time, Microsoft has tested many modules of OPTIMUM before. In 2011 Optimum ERP became certified for Windows Server 2008 R2. Now, Microsoft has changed their testing standards for Windows Server 2012, thus OPTIMUM has been enhanced a lot with .net Framework 4.

### How rigorous is the process to get this certification?

The process of qualifying server applications for Windows Server 2012 is similar to that for Windows Server 2008 R2. There are five Requirement Chapters for Logo certification, each chapter contains specific requirements that the application must meet.

Technical requirements include tests for the following:

- **Windows Installer best practices**
- **Setup and primary functionality tests**
- **Drivers and security**
- **Best practices**
- **Windows fundamentals**
- **Install and uninstall**
- **Security**
- **Reliability and high availability**
- **Hyper-V compatibility**

In order to be eligible for the Windows Server Application Certification Program Logo, the Microsoft Platform Ready Test Tool must be used to validate the Logo requirements. The test results will be generated by testing Server and Client components simultaneously and will be packaged using the MPR Tool into a single, passing package which can be uploaded to Microsoft for verification.

### What is the next level, or what comes next?

We at AI-Amthal strive to be abreast of the emerging technology. Twelve years ago we started with Visual Basic. Thereafter, we shifted to whatever new technologies had evolved at the time. Now we are up-to-date in technology, concepts, international practices and accreditations. As a trusted software vendor, we are committed to being up-to-date at all times, in all respects.




# Improved Customer Service

As part of its Quality Management System AI-Amthal has introduced improved measures of customer service enhancement via its new CRM system, which handles all customer requests and queries through a full automated ticketing system. The ticketing system allows our customers to log into a state-of-the-art customer support portal where customers raise a ticket regarding any concern they may have in connection with OPTIMUM, ECnet or NLink products and services.



The new CRM system has undergone significant changes and uplifts which have made the system even more user-friendly and productive. The system allows customers to register any inquiry, request or complaint online. An e-ticket number is automatically generated by the system and directly passed to the support coordinator, who acknowledges the receipt of each ticket immediately and passes it on to the account officer concerned.

From then on all correspondence is registered by the system and followed-up by the coordinator for quality purposes. The system also enables our customers to assign an importance level to their issue, to follow up on the status of each ticket they have raised and attach documents for clarification. The issues raised are segregated into two categories, i.e. support or customization that further assists in resolving the issue in a timely manner.



Any support follows a strict scheduling procedure for follow-up and task handling in order to keep our customers informed on any development or necessary adjournment. Managers and supervisors get daily reports on the status of tickets raised by customers. Thus, each issue receives its due attention and alerts of delays are immediately reported. The system will keep on reminding the staff concerned until the ticket issue is closed to the customers' satisfaction. AI-Amthal gives paramount importance to customer satisfaction and the new CRM system facilitates us to implement that quality policy efficiently and effectively.



### Facelift for The Coffee Room





## GM's Birthday


